Open Meeting

Kent Elliott called the Park Board meeting to order at 6:31pm.

Determination of Quorum

Consideration of Minutes

A motion to accept the May minutes were placed on the floor by Jim Pearcy and seconded by Elizabeth Whitaker. The motion passed 4-0.

New Business

- A. Shelter Alcohol Permit- Will Lacey stated that Anne Baenziger requested a one day alcohol use permit for a Shelter 2 rental on July 7, 2018. After no further discussion, a motion to accept the one day alcohol use permit for Shelter 2 rental on July 7, 2018 by Anne Baenziger was placed on the floor by Jim Pearcy and seconded by David Glover. The motion passed 4-0.
- B. Vandalism- Will Lacey stated that in the recent weeks the park had received multiple acts of spray paint on the tennis courts, both shelters, and bathrooms. As well as the destruction of a couple of picnic tables. Will Lacey stated we had been trying to use trail and security cameras, but the quality is not sufficient to identify the people. Will Lacey mentioned that the North Park restrooms are connected to a mag lock that uses a light sensor to turn them off and on, while having a panic bar on the inside for emergencies during the times they are locked.
- C. Trees- Will Lacey stated the trees are planted along the trail in Stratford as well as along the DAC trail.
- D. Handrails- Will Lacey stated the handrails for the DAC are in the process of being painted and it takes much longer than what was anticipated for this painting process, but will get them installed as soon as they are received.
- E. Blanton House- Will Lacey stated that we are waiting on a date from the company to come out and install gutters.

Old Business

- A. Amphitheater- Will Lacey stated that he is still working on getting the drawings.
- B. Black Vultures- Confirmed contract with Simon Davies to hang effigies to vacate the area in Eakin Park.
- C. Wayfinding- Waiting on the drawings for the front sign. Need to put in a couple of additional "One Way" signs in Ellis Park.

Reports

- A. YTD Financial Report- Profit & Loss statements have been reviewed by Park Board with no questions.
- B. DAC- Looking to hire a part time recreation programmer to fill the slot of Tara.
