DANVILLE SEEKS INTERESTED CITIZENS FOR BOARDS & COMMISSIONS

The Danville Town Council is accepting applications from Danville residents interested in serving on one of the following boards or commissions that have appointments in 2019: Plan Commission, Board of Zoning Appeals, Redevelopment Commission, Park Board, Citizens Advisory Board, Design Review Committee, Metropolitan Board of Police Commissioners, and Tree Advisory Committee.

The Plan Commission meets the second Monday of each month at 7:00 pm. There are two seats available. As required by state statute, one must be filled by a registered Republican and the other by a registered Democrat or registered Independent. These appointments are for a four (4) year term each.

The Board of Zoning Appeals meets the third Tuesday of each month at 7:00 pm. There are four (4) seats available. Three appointments are for a four (4) year term each and one (1) appointment is to complete the remaining two (2) years of a seat that was vacated early.

The Redevelopment Commission meets the second Thursday of each month at 5:30 pm. And four (4) members are appointed annually.

The Park Board meets the second Tuesday of each month at 6:30 pm. There is one (1) open seat which serves a four (4) year term.

The Citizens Advisory Board meets on an as needed basis and four (4) members are appointed annually.

The Design Review Committee meets on the first Monday of each month at 4:30 pm. There is one seat available. This appointment is made by the Plan Commission for a four (4) year term.

The Metropolitan Board of Police Commissioners meets the third Monday of each month at 6:00 pm. There are two (2) seats available and state statute requires that one (1) seat must be filled by a registered Republican and the other a registered Democrat or registered Independent. This term is a three (3) year appointment.

The Tree Advisory Committee meets quarterly at 6:00 pm. There are three (3) seats available and those are made annually.

Applications are available online at www.danvilleindiana.org or can be picked up at the Danville Town Hall Suite #120. Applications will be accepted through Friday, December 14, 2017. Appointments will be considered at the January 7, 2019 Town Council meeting.
