- B. **Opening Bid for Stratford Ridge Project**--Staff recommends bids be refereed to banning engineering for lowest most responsive bid *Seeking Counsel consensus*
- C. **Pay Ordinance**— Clerk/Treasurer Jenny Pearcy will be presenting an amendment to the pay ordinance to include the CSI position. *Seeking vote for approval*
- D. **Street Closure**—Tracie Shearer and or Kevin Hill will be requesting a street closure for their annual block party. *Seeking vote for approval*
